Essay outline and structure

Below is one possible structure for your essay. The nature of the self-study allows some flexibility in the specific structure although the elements identified below must be included.

Introduction: Focus	a) State the specific focus of your self-study and explain why.	500 words

step back and consider the 'state-of-the-actual'; discussing your own assumptions, beliefs and values in relation to the literature. You are thinking about who you are as a leader and perhaps negotiating some of the conflicts, contradictions, tensions and challenges involved – who you want to be is perhaps different from who you are right now or who others want you to be as a leader.

Remember that your critical discussion should always keep in mind the specific focus of your self-study, as identified in the first section.

In order to conduct your self-study you will need to engage in systematic data collection and analysis to interrogate practice. This will involve the creation and analysis of visual representations and 360° evaluations as well as any other relevant data gathered such as observations/documentation of your own practice.

Visual representation: you should include and discuss the visual representation of you as a leader you created as part of the course. You should explain the visual and discuss what this means in relation to literature about educational leadership. A photograph/image included in the main body of the text could count as 300-500 words. It should be included as part of the main text if it is necessary for the reader to see the image whilst reading the text and therefore not disrupting the flow by requiring the reader to turn to appendices. However it is also appropriate to include the visual representation as an appendix if it is easier for the reader to access and read the image.

360° Evaluation: you should discuss the key issues emerging from your 360° evaluation. You will reflect critically on how others perceive you and discuss this in relation to your own assumptions and beliefs as well as the literature. The collated data and full analysis should be in appendix – only key issues are raised and discussed in the main body.

Other evidence: there may be other forms of data that will help provide you with insights into your own practice and/or assumptions about leadership. Any evidence you collect and analyse should be included as an appendix and the key issues raised and discussed in the main body of the essay. Only include what is absolutely relevant and pertinent to the focus of your study.

	Policy: you will be reflecting on relevant policies at school, local and national levels (and international	
	if appropriate) and how these influence and inform you in terms of educational leadership. You should	
	include relevant annotated extracts of policies in the appendices and discuss the main aspects in	
	relation to the literature and your practice in the main body of the essay.	
Conclusion: Where	This final section should draw together your discussion and critical reflection of self. You should	500 words
